 - \$625 if the company is a Section16.net member and subscribes to the Section 16 Annual Service
 - \$1145 if the company only is a Section16.net member
- **For Law Firms**—Law firms, filing agents and others that file on behalf of other companies may enter a No-Risk Trial to the Filer at these rates per location:
 - Filing on behalf of one issuer/company: \$1145 if the firm is a Section16.net member and subscribes to the Section 16 Annual Service
 - Filing on behalf of one issuer/company \$1795 if the firm only is a Section16.net member
 - Filing on behalf of 2-5 issuers/companies: \$1795 if the firm is a Section16.net member and subscribes to the Section 16 Annual Service
 - Filing on behalf of 2-5 issuers/companies: \$2295 if the firm only is a Section16.net member
 - Filing on behalf of unlimited number of issuers/companies: \$2625 if the firm is a Section16.net member and subscribes to the Section 16 Annual Service
 - Filing on behalf of unlimited number of issuers/companies: \$3355 if the firm only is a Section16.net member
